Application Process

STEP 1

- Fill out application for admission form, return completed form and payment of non-refundable application fee to MTI.
- Application must include copies of past 3 years driving history, commercial and non-commercial, from each jurisdiction a license was held and a clear copy of both sides of your current driver's licence
- Complete IELTS Academic English Language Proficiency Test with a 6.0 score or higher. IELTS test results must be submitted with application. Please visit <https://www.ielts.org/> to find a testing station near you.

STEP 2

- Complete an over the phone pre-enrolment interview with MTI Instructor
- *Conditional* acceptance letter will be created upon successful completion of pre-enrolment interview, provided that all requirements in step one have been met.
- An invoice for tuition will be created and sent to you along with conditional acceptance letter. All invoiced fees are due before a *final* acceptance letter will be created.

STEP 3

- Complete / provide proof of the following to MTI:
 - Clean Criminal Record Check from your home country
